#### **ABSTRACT**

Department of Employment and Training - Training Wing - Conversion of Centre of Excellence (CoE) modules into Craftsman Training Scheme (CTS) trades in 9 Government Industrial Training Institutes (ITIs) - Rs.373.92 Lakh sanctioned for procurement of additional machinery, tools and equipment - Orders issued.

### **ORDER:**

In the letter third read above, the Director of Employment and Training has stated that, under the Government of India scheme of Upgradation of Government ITIs into Centres of Excellence, 19 Government ITIs were upgraded with CoE sectors viz., Automobile, Production and Manufacturing, Fabrication (Fitting & Welding), Hospitality Management, Plastic Processing Operator, Leather Goods Manufacturing, Information Technology, Construction and Wood Working and Electrical. But due to long duration of training and less employment opportunities, these sectors have become unpopular. Accordingly, Directorate General of Employment and Training (DGE&T), New Delhi had instructed vide their letter first read above, to convert these CoE courses into relevant CTS courses. Subsequently, in the Government Order second read above, ratification orders were issued for conversion of CoE courses into CTS trades in 10 Government ITIs at Ambattur, Madurai, Karaikudi, Dharmapuri, Guindy (Women), Coimbatore (Women), Guindy, Tuticorin, Thanjavur and Salem by the Director of Employment and Training, based on the above instruction of DGE&T.

2. The Director of Employment and Training has now proposed to convert the CoE modules into CTS trades in the remaining 9 Government ITIs at Chengalpattu. Coimbatore, Dharapuram, Hosur, Trichy, Cuddalore, North Chennai, Tirunelveli and

Vellore as detailed in the annexure to this Government Order, by utilizing the available infrastructure to the maximum extent. The Director of Employment and Training has stated that an additional expenditure of Rs.3,73,92,055/- is required towards procurement of tools & equipment required for the conversion of CoE modules into CTS trades in Government ITIs. The abstract of the expenditure required is given below:-

  - To permit to convert CoE modules into CTS trades in the remaining 9 Government ITIs as mentioned in the annexure to this Government Order and sanction a sum of Rs.373.92 Lakh as non-recurring expenditure for procurement of tools and equipment required for conversion of CoE modules into CTS trades.
  - To permit to utilize the existing regular and contract posts sanctioned for CoE for the converted CTS trades.
- To permit to utilize recurring cost towards raw materials as per G.O. (Ms.) No.197, Labour and Employment Department, dated 17.10.2019.
- To permit to make admission in CoE converted CTS trades from August 2020 session onwards.
- 4. The Government after careful examination, accept the proposal of the Director of Employment and Training and accordingly issue the following orders:
  - i. Permission is accorded to the Director of Employment and Training to convert CoE modules into CTS trades in 9 Government ITIs as detailed in the annexure to this Government Order and sanction is accorded for a sum of Rs.3,73,92,055/-(Rupees Three crore seventy three lakh ninety two thousand and fifty five only) as non-recurring expenditure towards procurement of tools and equipment required for conversion of CoE modules into CTS trades.

- ii. Permission is accorded to the Director of Employment and Training to utilize the existing regular and contract posts sanctioned for CoE for the converted CTS trades.
- iii. Permission is accorded to the Director of Employment and Training to meet recurring cost towards raw materials as per G.O. (Ms.) No.197, Labour and Employment Department, dated 17.10.2019.
- iv. Permission is also accorded to the Director of Employment and Training to make admission in CoE converted CTS trades from August 2020 session onwards.
