From the Director, Tamil Nadu Skill Development Corporation/Director of Employment and Training, RC.No.2099/SDC-1/2016-1, dated 8.12.2016.

ORDER:

The Hon'ble Chief Minister of Tamil Nadu has made an announcement to introduce a new scheme on 20.9.2016 as below:

“இந்த வருடம் அரசு தொழிற் பயிற்சி நிலையங்கள் அமைந்துள்ள 60 ஒன்றியங்களில் ஒவ்வொரு ஒன்றியத்திலும் 60 நபர்கள் என்ற அடிப்படையில் மொத்தம் 3600 பயிற்சியாளர்களுக்கு 3 மாதங்கள் பயிற்சி வழங்கப்படும். பயிற்சியின் போது, பயிற்சியாளர்களுக்கு மாதம் ஒன்றுக்கு 3000 ரூபாய் உதவித் தொகை வழங்கப்படும். இந்த திட்டத்திற்காக 2 கோடியே 94 லட்சம் ரூபாய் செலவிடப்படும்.

மேலும், சேவைத்துறை பணிகளான விற்பனையாளர், கணக்காளர், பாதுகாப்பு சேவை புரிபவர், செவிலியர் / சுகாதார உதவியாளர் மற்றும் நிறுவன நேர்த்தி (House Keeping) போன்ற பணிகளுக்கான திறன்களை மேம்படுத்தும் பயிற்சிகள், மாநகராட்சி, நகராட்சி மற்றும் பேரூராட்சி பகுதிகளில் உள்ள 20000 இளைஞர்களுக்கு தமிழ்நாடு திறன் மேம்பாட்டுக் கழகத்தின் மூலம் வழங்கப்படும். இந்த பயிற்சி திட்டம் 18 கோடி ரூபாய் செலவில் செயல்படுத்தப்படும்”

2. Based on the above announcement, the Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training has proposed to provide Skill Development Training in 60 Panchayat Union

where there are Government Industrial Training Institutes and Skill Training in Service Sector through Private Training Providers as below:

I. Skill Development Training in 60 Panchayat Union where there are Government Industrial Training Institutes

Self – employment based courses viz., Domestic Electrician, Arc & Gas Welding, Maintenance of Air-conditioners, Tailor, Accounts Assistant using tally etc., will be imparted in 60 Panchayat Union as in the annexure to this order where there are Government Industrial Training Institutes

a) Courses to be imparted

Course Curriculum will be based on National Occupational Standard (NOS) / Qualification Package (QP) and approved by Sector Skill Council (SSC) and Directorate General of Training, Ministry of Skill Development and Entrepreneurship, New Delhi under National Skill Qualification Framework (NSQF) or syllabus approved under SDI-MES Scheme.

b) Capacity & Staff arrangement :

Two courses in great demand with self employment opportunity shall be started with a batch size of 30 each based on the infrastructure available in the selected institutes. Qualified instructors with relevant qualification and experience shall be engaged to impart training through OMCL. Honorarium and other allowance shall be fixed as per norms.

c) Eligibility

Educational Qualification: As prescribed in the syllabus of SDI-MES or Sector Skill Council of the respective sectors.

Minimum Age : 18 years and no upper age limit.

d) Target group :

Unemployed youth in the State (both men and women).

e) Course duration and Time

Course duration will be three months (3 hours per day on week days (and) (or) 8 hours per day on holidays (Saturday, Sunday and Government holidays) - totally restricted to 100 hours per month).

f) Non recurring expenditure

A sum of Rs 0.50 lakh per centre shall be sanctioned for procurement of shortage / additional infrastructure required for 60 institutes which works out to Rs.30.00 lakhs.

g) Recurring expenditure

The expenditure has been calculated on the basis of 30 per batch to be trained for 300 hours course (approximately) for instructors.

*The cost arrived above is tentative, it may differ based on the course selected and course duration but overall expenditure will be incurred within the sanctioned amount of Rs 18.00 Crores.

The Tamil Nadu Skill Development Corporation will identify Training Partners to conduct the training programme in the sectors as per QP & NOS.

3. The Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training has requested the Government to issue the following orders.

1. To establish skill training centers to train 3600 candidates at 60 Panchayat Unions through Government Industrial Training Institutes as in the annexure at a cost of Rs.2.94 Crores.
2. Institute Development Committee of the Industrial Training Institutes to conduct the training by outsourcing qualified faculty outsourced from Overseas Manpower Corporation and to incur the expenditure through the funds received from Tamil Nadu Skill Development Corporation.
3. To conduct skill training to 20,000 youth in service sector through training partners and to sanction a sum of Rs. 18 crore towards training cost, transportation cost / Boarding and Lodging cost.

4. The Government have carefully examined the proposal of the Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training accept it and issue the following orders:

- i. The Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training is permitted to establish skill training centers to train 3600 candidates at 60 Panchayat Unions through Government Industrial Training Institutes as in annexure to this order at a cost of Rs.2.94 Crore.
- ii. The Institute Development Committee of the Government Industrial Training Institutes are permitted to conduct the training by outsourcing qualified faculty outsourced from Overseas Manpower Corporation and to incur the expenditure through the funds received from Tamil Skill Development Corporation.

- iii. The Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training is permitted to conduct skill training to 20,000 youth in service sector through training partners at a cost of Rs. 18 crore towards training cost, transportation cost / Boarding and Lodging cost.
- iv. Sanction is accorded for a sum of Rs.20.94 crore from the funds of Tamil Nadu Skill Development Corporation.
- v. The Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training is requested to get ratification from the Board of Directors of Tamil Nadu Skill Development Corporation for sanction of funds from Tamil Nadu Skill Development Corporation.




