ORDER:

The Hon'ble Chief Minister of Tamil Nadu had made the announcement to introduce the following new scheme on 20.9.2016.

“அம்மா இரு சக்கர வாகன பழுதுபார்க்கும் பயிற்சி மையம் ஏற்படுத்தப்பட்டு குறுகியகால பயிற்சி வழங்கப்படும். இந்த பயிற்சி பெற்றவர்களுக்கு சுயதொழில் துவங்க உதவிகள் வழங்கப்படும். அதன்படி முதற்கட்டமாக இந்த ஆண்டு அரசு தொழிற் பயிற்சி நிலையங்கள் அமைந்துள்ள 35 ஊராட்சி ஒன்றியங்களில் இரு சக்கர வாகன பழுதுபார்ப்பு மற்றும் பராமரிப்பு பயிற்சி நிலையம் அமைக்கப்படும். இந்த நிலையங்கள் அமைந்துள்ள ஊராட்சி ஒன்றியங்கள் ஒவ்வொன்றிலும் 30 பேருக்கு 3 மாதங்களுக்கு பயிற்சி வழங்கப்படும். பயிற்சி காலத்தில் பயிற்சியாளர்களுக்கு மாதாந்திர உதவித் தொகையாக 3000 ரூபாய் வழங்கப்படும். இத்திட்டம் 1 கோடியே 68 லட்சம் ரூபாய் செலவில் செயல்படுத்தப்படும்.”

2.Providing training in repair & maintenance of two wheelers and agricultural machineries not only generates self-employment to the trainees but also paves a way for the manufacturers of automobiles, agricultural machineries to employ trained youth in their show rooms and service centers spread across the state generating more employment opportunities to the rural youth in the State.



3. In the letter read above, the Director, Tamil Nadu Skill Development Corporation / Director of Employment and Training has proposed for starting of AMMA Two Wheeler Repair & Maintenance Training Centers at 35 Government Industrial Training Institutes (as in annexure) where Mechanic Motor Vehicle, Mechanic Diesel and Mechanic Tractor trades are available. He had stated that the trainees of these institutes will be trained as two wheeler mechanics to carry out repairs in two wheelers and also trained in repair of small agricultural machineries and tractors which will help create self-employment opportunities for rural youth. He has further added that in the first phase, training will be imparted in 35 Government Industrial Training Institutes (as in the annexure) to the candidates in the block in which the Industrial Training Institutes is located. While conducting training in the nearby blocks, the machinery and equipments available in the Industrial Training Institute will be shifted to the community centers available in the respective blocks to provide training to youth in that block. Subsequently more blocks will be covered by shifting the machinery and equipments available in Government Industrial Training Institutes to train candidates in all other blocks in the state where there is demand for two wheeler machineries and Agro service centers to repair agricultural machineries.

4. He has proposed to provide specific training in Two Wheeler Repair and Maintenance and agricultural machineries by utilizing the existing infrastructure, machinery and equipments available with Government training providers i.e. Industrial Training Institutes empanelled by Tamil Nadu Skill Development Corporation with the following features.

#### INFRASTRUCTURE

a) No new infrastructure will be created except the purchase of three two wheelers for each Industrial Training Institute (35 in number). Training will be conducted in Government Industrial Training Institutes which are already having Mechanic (Motor Vehicle) / Mechanic (Diesel)/ Tractor Mechanic trades and all necessary infrastructural facilities and machineries for conducting these courses.

#### b) Course Name

Automotive Service Technician ( Two Wheeler + Three Wheeler / Light Motor Vehicle / Power Tillers / Agriculture & Allied Machineries) depending upon the need of the local industry.

#### c) Eligibility

Educational Qualification : 5th Pass

Minimum Age : 18 years and no upper age limit.



d) Target group :

Unemployed youth and school drop outs in the State (Both men and women).

e) Syllabus

Syllabus already developed by Sector Skill Council viz., National Occupational Standard (NOS) / Qualification Package (QP) and approved by Directorate General of Training, Ministry of Skill Development and Entrepreneurship, New Delhi under National Skill Qualification Framework (NSQF) or the syllabus followed under SDI-MES scheme will be adopted.

f) Capacity and Staff arrangement

One batch shall be started with a batch size of 20 trainees each based on the infrastructure available with the Government Industrial Training Institutes. Qualified retired instructors / resource persons with relevant qualification and experience shall be engaged to impart training which will not affect the regular training programme. Honorarium shall be paid to the appointed instructors on hourly basis as per courses on works of Government of India / Tamil Nadu Skill Development Corporation. Honorarium shall be fixed on par with schemes such as PMKVY, MES etc., for similar qualification and experience.

g) Course duration and Time

Course duration will be four months (4 hours per day x 20 days per month totally restricted to 300 hours). The training will take place preferably from 3.p.m to 6 p.m.

h) Funding

The funds shall be met out from the funds available at Tamil Nadu Skill Development Corporation (TNSDC), Chennai.

i) Expenditure InvolvedNon recurring expenditure

Three two wheelers shall be procured for each institute for which a sum of Rs.2.00 lakhs to each of 35 Industrial Training Institutes having the trade of Motor Mechanic Vehicle / Diesel Mechanic / Tractor Mechanic shall be sanctioned. Total expenditure works out to Rs 70.00 lakhs.

Recurring expenditure

For conducting training in 35 Panchayat Unions, the expenditure towards honorarium, raw materials, consumables and stipend as detailed below has been calculated on the basis of 20 candidates per batch to be trained for 300 hours course.

5. The Director, Tamil Nadu Skill Development Corporation /Director of Employment and Training has requested the Government to permit Tamil Nadu Skill Development Corporation to start AMMA Two Wheeler Repair and Maintenance Center to train candidates at 35 Panchayat Unions through Government Industrial Training Institutes at a cost of Rs.1.40 crores and to permit the Institute Development Committee of the ITIs to conduct the training by outsourcing qualified faculty from Overseas Manpower Corporation and to incur the expenditure through the funds received from Tamil Nadu Skill Development Corporation.

6. The Government carefully examined the proposal of the Director, Tamil Nadu Skill Development Corporation /Director of Employment and Training accept it and issue the following orders:



i) Permission is accorded to the Director, Tamil Nadu Skill Development Corporation /Director of Employment and Training to start AMMA Two Wheeler Repair and Maintenance Center to train 700 candidates at 35 Panchayat Unions through Government Industrial Training Institutes (as in annexure) at a cost of Rs.1.40 crores as in para 4 above.

ii) Permission is accorded to the Institute Development Committee of the Industrial Training Institutes to conduct the training by outsourcing qualified faculty from Overseas Manpower Corporation.

iii) The expenditure shall be met out through the funds received from Tamil Nadu Skill Development Corporation.

iv) The Director, Tamil Nadu Skill Development Corporation /Director of Employment and Training shall take necessary action to get ratification from the board of directors of Tamil Nadu Skill Development Corporation for the sanction of funds.
