



Announcement made by the Hon'ble Chief Minister under Rule 110 of Tamil Nadu Legislative Assembly during the Assembly Session 2019-2020 - Starting of two new Government Industrial Training Institutes at Perumbakkam in Kancheepuram District and Sembodai in Nagapattinam District in collaboration with Power Grid Corporation of India Limited and Bharat Petroleum Corporation Limited respectively - A sum of Rs.379.37 Lakh towards recurring cost for starting of two Industrial Training Institutes - Sanctioned - Orders issued.

ORDER:

During the Assembly Session 2019-2020, the Hon'ble Chief Minister of Tamil Nadu has made the following announcement under Rule 110 on the floor of Assembly on 12.07.2019:-

"பொதுத் துறை நிறுவனங்களான பவர்கிரிட் கார்ப்பரேஷன் இந்தியா லிமிடெட் மற்றும் பாரத் பெட்ரோலியம் கார்ப்பரேஷன் லிமிடெட் ஆகிய நிறுவனங்களின் சமூக பங்களிப்புடன் காஞ்சிபுரம் மாவட்டம் – பெரும்பாக்கம் மற்றும் நாகப்பட்டினம் மாவட்டம் – செம்போடை ஆகிய இரண்டு இடங்களில் புதிய அரசு தொழிற்பயிற்சி நிலையங்கள் 26 கோடி ரூபாய் செலவில் துவக்கப்படும்."

- 2. In the letter 1st read above, the General Manager, Power Grid Corporation of India Limited (POWERGRID) has agreed to establish Industrial Training Institutes (ITIs) in untapped areas in terms of infrastructural facilities in phased manner on the land to be procured and provided by the State with physical possession free of cost to POWERGRID as per the PM's Vision New India 2022 Action Plan of CPSE Conclave.
- 3. In the letter 4th read above, an in-principle approval has been accorded for setting up of two new ITIs at Perumbakkam in Kancheepuram District and Sembodai in Nagapattinam District by Power Grid Corporation of India, as per PM's Vision New India 2022 Action Plan of CPSE Conclave as was proposed by the Commissioner of Employment and Training in her letter 2nd read above.
- 4. Meanwhile, the Executive Director (HRS), Bharat Petroleum Corporation Limited, Mumbai, in the letter third read above, has stated that, under Vision New India 2022, one of the action point is to set up ITIs by Maharatna Central Public Sector Undertakings (CPSEs) in select locations in the country with an objective to support Skill India and hence has proposed to set up one such ITI in Tamil Nadu.
- 5. Hence, the Commissioner of Employment and Training, in her letter 5th read above, has proposed to start the Government ITI, Perumbakkam, Kancheepuram District in collaboration with Power Grid Corporation India Limited, Bengaluru and the Government ITI, Sembodai, Nagapattinam District in collaboration with Bharat Petroleum Corporation Limited, Mumbai and has stated the role of the State and the Public Sector Undertakings of Government of India in setting up of the Industrial Training Institutes under the above scheme as below:-

(i) Role of State

The State Government will provide the required land as per prevailing norms and also bear the recurring cost viz., staff salary and administration cost for these ITIs. Administration of the ITIs vests with State Government.

(ii) Role of Public Sector Undertakings of Government of India

The non-recurring expenditure regarding construction of ITI building and hostel building and procurement of machinery, tools & equipments will borne by the Power Grid Corporation of India Limited, Bengaluru and Bharat Petroleum Corporation Limited, Mumbai under their CSR activities.

6. The Commissioner of Employment and Training has sent the proposal for starting of two new Government ITIs at Perumbakkam and Sembodai in the following locations identified by the State Government:-

- 7. The Commissioner of Employment and Training has furnished the details of trades to be started, civil estimates, cost of tools and equipments, staff details and administrative expenses in detail for setting up of two new Government ITIs at Perumbakkam and Sembodai and has requested to issue the following orders:-
 - Permission to start two new Government ITIs in the places identified at Perumbakkam and Sembodai in collaboration with Power Grid Corporation India Limited, Bengaluru and Bharat Petroleum Corporation Limited, Mumbai respectively.
 - ii. To approve the trades to be started in each new ITI.
 - iii. To sanction the required number of staff for each ITI.
 - iv. To sanction the Hostel and related staff in each ITI.
 - v. To permit to incur the expenditure on creation of infrastructure viz., Construction of ITI and hostel buildings, Procurement of machinery, tools & equipments, Computers and furniture required for the Industrial Training Institutes as per NCVT norms through Power Grid Corporation India Limited, Bengaluru and Bharat Petroleum Corporation Limited, Mumbai.
 - vi. To permit the Principal of the each ITI to open the PD account in the existing procedure.
 - vii. To permit to run the two New ITIs in the rental building as identified by the respective Principals and Regional Joint Directors.
- viii. To permit to pay the rent fixed by the respective PWD authorities.

- ix. To permit to start the courses under State Council for Vocational Training (SCVT) pattern and to issue certificate by the SCVT through the Department of Employment and Training initially. After equipping all the facilities National Council for Vocational Training (NCVT) affiliation shall be obtained.
- x. To sanction an amount of Rs. 379.37 towards administrative expenses including Salaries to staff, Office expenses, Scholarship and Stipend to students, Stationery and Maintenance of Computers, etc., as recurring cost for starting of two new Government ITIs at Perumbakkam and Sembodai.
- 8. The Government after careful examination, accept the proposal of the Commissioner of Employment and Training and issue the following orders:-
 - Permission is accorded to start two new Government ITIs in the places identified at Perumbakkam, Kancheepuram District and Sembodai, Nagapattinam District in collaboration with Power Grid Corporation India Limited, Bengaluru and Bharat Petroleum Corporation Limited, Mumbai respectively, as mentioned in para 6 above.
 - ii. Permission is accorded to the Commissioner of Employment and Training to start the trades in each new ITI as in Annexures I & VIII.
 - iii. Sanction is accorded for creation of staff for each ITI as in Annexures IV & XI.
- iv. Sanction is also accorded for creation of staff for the Hostel in each ITI as in the Annexures V & XII.
- v. Permission is accorded to incur the expenditure on creation of infrastructure viz., Construction of ITI and hostel buildings, procurement of machinery, tools & equipments, Computers and furniture required for the Industrial Training Institutes as per NCVT norms through Power Grid Corporation India Limited, Bengaluru and Bharat Petroleum Corporation Limited, Mumbai as in the Annexures VII & XIV.
- vi. Permission is accorded to the Principal of the each ITI to open the PD account in the existing procedure.
- vii. Permission is accorded to run the two new ITI in the rental building as identified by the respective Principals and Regional Joint Directors.
- viii. Permission is accorded to pay the rent fixed by the respective PWD authorities.
- ix. Permission is accorded to start the courses under State Council for Vocational Training (SCVT) pattern and to issue certificate by the SCVT through the Department of Employment and Training initially. After equipping all the facilities, National Council for Vocational Training (NCVT) affiliation shall be obtained.

- x. Sanction is accorded for an amount of Rs. 379.37 Lakh (Rupees Three Crore Seventy nine Lakh and thirty seven thousand only) towards administrative expenses as recurring cost for starting of two new Government ITIs at Perumbakkam and Sembodai and debit it into the Heads of Account 2230 03 101 KC starting of new ITIs as detailed in Annexures VI & XIII.
- 9. The expenditure sanctioned in paragraph "8(x)" above has been included in the First Supplementary Estimates (FSE-I) 2019-2020 (item -11) and the Commissioner of Employment and Training is authorized to incur the expenditure sanctioned in para 8(x) above.
- 10. This order issues with the concurrence of Finance Department vide its U.O.No.36215/L&E /2019, dated 31.07.2019.
