ORDER:

The Hon'ble Chief Minister has made the following announcement on the floor of Assembly under rule 110 on 13.5.2013.

"A new building for Government Industrial Training Institute (Women), Karur in Karur District will be constructed at a cost of Rs.2.00 crore."

2. The Government Industrial Training Institute (Women), Karur was started in the year 2003 exclusively for women and is functioning with 3 trades, and a sanctioned strength of 126 in a rental building. The Women trainees face difficulties in taking their skill training due to inadequate facilities and they should be made free from any hardship at their place of training. The Hon'ble Chief Minister has announced to construct a new building to Government Industrial Training Institute (women), Karur at a cost of Rs.2.00 crore, with adequate facilities for Laboratories, Class rooms, Library, Office rooms etc.

3. Accordingly, the Director of Employment and Training has submitted the following proposal for construction of new

Proposed Expenditure for the Civil Work

1. Workshop/Classroom/ Administrative Block	- 189.20 lakhs
2. Power wiring	- 10.80 lakhs

Total	200.00 lakhs

The District Collector, Karur has allotted and identified a location of 0.81.0 hectare (Prompoke parai) in S.No.276/2, at Achimangalam Village, Karur Taluk, Karur District for the construction of new Industrial Training Institute building. The Director of Employment and Training had also submitted the rough cost estimate obtained from the concerned Public Works Department authorities for the above work.

4. Hence, the Director of Employment and Training has requested to sanction a sum of Rs.2.00 crore during the year 2013 - 14 for the construction of own building to Government Industrial Training Institute (Women) Karur.

5. The Government have carefully examined the proposal and permit the Director of Employment and Training to construct a new building to Government Industrial Training Institute (women), Karur in survey no.276/2, at Achimangalam Village, Karur T.K., & Karur District and to sanction a sum of Rs.2.00 crore (Two crore only) towards construction of new building to the Karur (Women) Industrial Training Institute, as per the plan approved by the Public Works Department Authorities at 1494 Sq. metres.

6. The expenditure sanctioned in para 5 above is debitable to the following head of account.

"4250 - 00 - Capital outlay on Other Social Services -
203 - Employment - II State Plan - JG - Development
of ITIs - Land and Buildings - 16 - Major works.

7. The expenditure sanctioned in paragraph "5" above constitute an item of "New Instrument of Service. The approval of the Legislature will be obtained in due course. Pending approval of the Legislature the expenditure will initially be met from an advance drawn from the contingency fund orders regarding which will be issued separately in

building for the Government Industrial Training Institute (Women), Karur.
