ORDER:

In the G.O. first read above, orders were issued to sanction a sum of Rs.716.42 lakhs towards setting up of Language cum Soft Skill Lab in 35 Government Industrial Training Institutes. Subsequently, orders were issued to sanction a sum of Rs.300.00 lakhs towards construction and power wiring cost and lab infrastructure in respect of setting up of language cum soft skill lab in 12 Government Industrial Training Institutes vide G.O. second read above.

2. During the Budget session 2016-17, the Hon'ble Minister for Labour had made the following announcement in the floor of the Assembly on 16.08.2016:-

3. In the letter third read above, the Director of Employment and Training has proposed for setting up of Language Cum Soft Skill Lab in 17 Government Industrial Training Institute viz. Ambai, Mudukulathur, Namakkal(W), Tenkasi, Ambattur(W), Madurai(W), Nagarcoil(W), Andimadam, Pullambadi, Ramanathapuram, Sivagangai, Salem(W), V.K. Pudur, Coimbatore (W), Nagapattinam, Theni and Tuticorin as detailed below:-

4. The Director of Employment and Training has requested the Government to issue the following orders for setting up of language cum soft skill lab in 17 Government Industrial Training Institutes:-

- Permission to create infrastructure facilities as per the requirement in 17 Government Industrial Training Institutes.
- To permit to construct new Lab building and provide power wiring as per need.

- iii. To sanction a sum of Rs. 517.96 lakhs (Recurring & Non Recurring) towards the expenditure for setting up of language cum Soft skill lab in 17 Government Industrial Training Institutes.
- iv. Creation of 17 contract instructor posts to handle IT Skill and Employability skill classes.
- v. Permission to outsource the trainers through ICT Academy of Tamil Nadu, Chennai / Overseas Manpower Corporation Limited, Chennai on contract basis.
- vi. To fix the monthly consolidated pay of Rs. 20,000 /- per trainer for the outsourced trainers.
- vii. Permission to conduct test and issue certificates by ICT Academy of Tamil Nadu / State Council for Vocational Training in association with Tamil Nadu Skill Development Corporation in IT skills or to adopt the pattern of Examination as decided by National Council for Vocational Training in future.

5. The Government after careful examination accept the proposal of Director of Employment and Training and permit to set up Language cum soft skill lab in 17 Government Industrial Training Institutes as detailed in para 3 above and issue the following orders.

- (i) Permission is accorded to create infrastructure facilities as per the requirement in 17 Government ITIs.
- (ii) Permission is accorded to construct new lab buildings and provide power wiring as per need.
- (iii) Permission is accorded for creation of 17 contract instructor posts to handle IT Skill and Employability skill classes.
- (iv) Permission is accorded to outsource the trainers through ICT Academy of Tamil Nadu/ Overseas Manpower Corporation Ltd., Chennai on contract basis.
- (v) Permission is accorded to fix the monthly consolidated pay at the rate of Rs.20,000 /- per trainer for the outsourced trainers.
- (vi) Permission is accorded to conduct test and issue certificates by ICT Academy of Tamil Nadu / State Council for Vocational Training in association with Tamil Nadu Skill Development Corporation in IT skills or to adopt the pattern of examination as decided by National Council for Vocational Training in future.

- (vii) Sanction is accorded for a sum of Rs.517.96 lakhs (Rupees Five crores seventeen lakhs and ninty six thousand only) towards the expenditure to set up language cum soft skill lab in 17 Government Industrial Training Institutes as detailed in para 3 above.

6.The expenditure sanctioned in para 5(vii) above shall be debitabale to the following heads of account.

The Director of Employment and Training is directed to calculate the actual amount required for the period upto next Supplementary Estimates and apply for sanction of the same as advance from the contingency fund Finance (BG-I) Department directly in Form A appended to the Tamil Nadu Contingency Fund Rules 1963 along with a copy of this order. Orders for sanction of an advance from the Contingency Fund will be issued from Finance (BG-I) Department. The Director of Employment and Training is also directed to send necessary explanatory notes to include the above expenditure in the Supplementary Estimates for the year 2017-18 to Government in Finance (RD) Department at the appropriate time without fail.


