ORDER:

In the letter 1st read above, the Directorate General of Training, Ministry of Skill Development and Entrepreneurship, Government of India, New Delhi has conveyed the sanction of President of India to release an amount of Rs.1,79,00,000/- to the 3 Private ITIs (Don Bosco Private ITI, Trichy, Ramco Private ITI, Virudhunagar and PAC Ramasamy Raja Private ITI, Ariyalur) towards 40% advance of approved ISP funding for incurring the expenditure under the component Result Area – 1 (RA-1) on signing of Performance Based Grant Agreement (PBGA) under the project "Skill Strengthening for Industrial Value Enhancement (STRIVE)" with World Bank assistance.

2. The ITIs are eligible for an advance of 40% on signing the PBGA as per Section 3.1.6 – Key Performance Indicators and Fund allocation of the Operations Manual. The details of the proposed release for 3 Private ITIs as per eligible expenditure of ISP is tabulated below :-

 - i. Chairman of the IMC - Chairperson
 - ii. Regional Joint Director - Vice Chairperson
 - iii. Principal of the Project ITI - Member / Convenor
 - iv. Nominated Senior faculty member - Member
 - v. One nominated Industry member – Member
- v. To permit the IMC Society to make Procurement under Result Area 1 as per the approved procurement plan. The annual procurement plan submitted by the ITI must conform to the guidelines mentioned in the manual.

- vi. To permit the IMC Society of Private project ITIs to execute activities that include procurement of machinery, tools, raw material, trade related furniture & fixtures, e-learning material etc. conforming to guidelines stipulated in the clause 4.2.1 of Operations Manual of STRIVE project in accordance with the principles outlined in "Canons of Financial Propriety".
- vii. To delegate necessary financial powers to competent authorities of the IMC Society as per section 4.2.4 of Operations Manual of STRIVE Project, which will apply solely to the STRIVE project activities

4. The Government after careful examination of the proposal of Director of Employment and Training, decides to accept the same and issue the following orders :-

- i. Sanction is accorded for the release of amount of Rs.1,79,00,000/- (Rupees One Crore Seventy Nine Lakh only) to the 3 Private ITIs (Don Bosco Private ITI, Trichy, Ramco Private ITI, Virudhunagar and PAC Ramasamy Raja Private ITI, Ariyalur) towards 40% advance of approved ISP funding for incurring the expenditure under the component Result Area – 1 (RA-1) on signing of Performance Based Grant Agreement (PBGA) under the project "Skill Strengthening for Industrial Value Enhancement (STRIVE)" with World Bank assistance.
- ii. Permission is accorded to the Director of Employment and Training to release the 40% grant of Rs.1,79,00,000/- (Rupees One Crore Seventy Nine Lakh only) to the Institute Management Committee Society of 3 Private ITIs as detailed below to carry out the project activities under Result Area 1 of STRIVE scheme :-

Permission is accorded to the IMC Society of Private Project ITIs to execute activities that include procurement of machinery, tools, raw material, trade related furniture & fixtures, e-learning material etc. conforming to guidelines stipulated in the clause 4.2.1 of Operations Manual of STRIVE project in accordance with the principles outlined in “Canons of Financial Propriety”.
