

ABSTRACT

Department of Employment and Training – State Project Implementation Unit (SPIU) - Centrally Sponsored 'Skills Strengthening for Industrial Value Enhancement (STRIVE)' Project – Sanction of an amount of Rs.9,77,00,000/- released by Government of India to 13 Government Industrial Training Institutes (ITIs) to carry out project activities under the component Result Area 1 of STRIVE Scheme - Orders issued.

ORDER:

In the letter first read above, the Directorate General of Training, Ministry of Skill Development and Entrepreneurship, Government of India, New Delhi has conveyed the sanction of President of India to release an amount of Rs.11.56 Crore to the 13 Government ITIs and 3 Private ITIs towards 40% advance of approved ISP funding for incurring expenditure under the component Result Area – 1 (RA-1) on signing of Performance Based Grant Agreement (PBGA) under the project "Skill Strengthening for Industrial Value Enhancement (STRIVE)" with World Bank assistance.

2. The ITIs are eligible for an advance of 40% on signing the PBGA as per Section 3.1.6 – Key Performance Indicators and Fund allocation of the Operations Manual. The details of the proposed release for 16 ITIs as per eligible expenditure of ISP is tabulated below:-

- 3. In the letter second read above, the Director of Employment and Training has requested the Government to issue the following orders:-
- i) To sanction an amount of Rs.977.00 Lakh released by Government of India towards 40% advance grant for the 13 Government Industrial Training Institutes of the state covered under the STRIVE project to incur the expenditure under the component Result Area –1 (RA-1) Improving the performance of ITIs.
- ii) To permit the Director of Employment and Training to draw and disburse the released amount to the Institute Managment Committee(IMC) Society of 13 Government ITIs namely Ambattur, Coimbatore, Chengalpattu, Madurai, Dindigul, Trichy, Perambalur, Cuddalore, Salem, Thoothukudi, Virudhunagar, Namakkal (W) and Sivagangai to carry out the project activities under Result Area 1 of STRIVE scheme through the SVEETS Society.

- iii) To permit the IMC Societies of above 13 Government ITIs to take up the activities as per the conditions stipulated in the Operations Manual.
- 4. The Government after careful examination of the proposal of Director of Employment and Training have decided to accept the same and issue the following orders:-
- i) Sanction is accorded for the release of amount of Rs.9,77,00,000/- (Rupees Nine Crore Seventy Seven Lakh only) to the 13 Government ITIs namely Ambattur, Coimbatore, Chengalpattu, Madurai, Dindigul, Trichy, Perambalur, Cuddalore, Salem, Thoothukudi, Virudhunagar, Namakkal (W) and Sivagangai towards 40% advance of approved ISP funding for incurring the expenditure under the component Result Area–1 (RA-1) on signing of Performance Based Grant Agreement (PBGA) under the project STRIVE with World Bank assistance.
- ii) Permission is accorded to the Director of Employment and Training to draw and disburse the above released amount to the IMC Societies of 13 Government ITIs to carry out the project activities under Result Area 1 of STRIVE scheme through the SVEETS Society.
- iii) Permission is accorded to the IMC societies of above 13 Government ITIs to take up the activities as per the conditions stipulated in the Operations Manual.
