ORDER:

In the Government Order first read above, among others, orders have been issued to continue State Project Implementation Unit at Headquarters to carry out the works related to the World Bank assisted Skills Strengthening for Industry Value Enhancement (STRIVE) project in Tamil Nadu. In Government Order, second read above, orders were issued permitting the Director of Employment and Training to start World Bank assisted STRIVE project in Tamil Nadu.

2. In the letters fifth read above, the Director of Employment and Training has submitted following proposal under Result Area 2 (Increased Capacity of State Governments to support ITIs and Apprenticeship Training) of STRIVE project:-

- i. In accordance to clause 3.2.6 of Operations Manual of STRIVE project, the participating States can utilize incentive funds released under Result Area 2 with the approval from the State Steering Committee (SSC).
- ii. Tamil Nadu is eligible for a grant of Rs.10.20 crore to carry out the activities under Result Area 2 of STRIVE project.
- iii. Out of eligible Rs.10.20 crore for Result Area 2 in STRIVE project in Tamil Nadu, 30% advance grant of Rs.3.06 crore shall be released on signing of Performance Based Funding Agreement (PBFA). Of this amount, a sum of Rs.1.27 crore had already been released by the State.

- iv. In the letter third read above, the Government of India has released the balance sum of Rs.1.79 crore for the proposed activities covered under Result Area 2 of STRIVE project. The same has been released vide Government Order fourth read above.

3. The Director of Employment and Training has therefore requested to issue the following orders based on the resolutions adopted by SSC meeting held on 23.10.2020:-

- (i) To issue orders approving the action of the Director of Employment and Training in cancelling the work order issued to M/s. BSNL after deducting a sum of Rs.9.36 lakh for hiring of Cloud Service for the period from February 2020 to August 2020 and also to issue ratification orders for hiring of Cloud Services for a period of three years through M/s. TNeGA for hosting the DET portal on Tamil Nadu State Data Centre for a period of 3 years from September 2020 onwards at an estimate of Rs.29.46 lakh.
- (ii) To issue orders according permission to incur the balance amount of Rs.87.15 lakh from the second tranche of release made by Government of India, in addition to the already released advance amount of Rs.9.77 lakh under Result Area 2 for establishing the Language cum Soft Skill Labs in -
- 1) Government ITI (ST), Anaicutti,
 - 2) Government ITI (ST), Gudalur,
 - 3) Government ITI (ST), Karumandurai,
 - 4) Government ITI (ST), Kolli Hills,
 - 5) Government ITI (ST), Jamunamaruthur, and
 - 6) Government ITI, Ulundurpet.
- (iii) To accord permission to incur a sum of Rs.10.00 lakh to upgrade the existing portal of Training Wing of the Department of Employment and Training, namely, www.skilltraining.tn.gov.in by adopting norms prescribed as per Tamil Nadu Tender Transparency Act.
- (iv) To ratify the action of the Director of Employment and Training for releasing of Rs.10,000/- each to 88 Government ITIs and Rs.15,000/- as additional fund for Government ITI, Gudalur amounting to Rs.8.95 lakh for the advocacy and publicity expenditure incurred towards disseminating the online admission process for 2020 admission session under Result Area 2.

4. The Government after careful examination of the proposal of the Director of Employment and Training, issue the following orders under Result Area 2 of STRIVE project:-

- (i) The action of the Director of Employment and Training in cancelling the work order issued to M/s. BSNL after deducting a sum of Rs.9.36 lakh for hiring of cloud service for the period from February 2020 to August 2020 is approved and hiring of cloud services for a period of three years through M/s. TNeGA for hosting the Department of Employment and Training portal on Tamil Nadu State Data Centre for a period of 3 years from September 2020 onwards at an estimate of Rs.29.46 lakh is hereby ratified.

(ii) Permission is accorded to incur the balance amount of Rs.87.15 lakh from the second tranche of release made by Government of India, in addition to the already released advance amount of Rs.9.77 lakh under Result Area 2 for establishing the Language cum Soft Skill Labs in:-

- 1) Government ITI (ST), Anaicutti,
- 2) Government ITI (ST), Gudalur,
- 3) Government ITI (ST), Karumandurai,
- 4) Government ITI (ST), Kolli Hills,
- 5) Government ITI (ST), Jamunamaruthur, and
- 6) Government ITI, Ulundurpet.

(iii) Permission is also accorded to incur a sum of Rs.10.00 lakh to upgrade the existing portal of Training Wing of the Department of Employment and Training, namely, www.skilltraining.tn.gov.in by adopting norms prescribed as per Tamil Nadu Tender Transparency Act.

(iv) The action of the Director of Employment and Training for releasing of Rs.10,000/- each to 88 Government ITIs and Rs.15,000/- as additional fund for Government ITI, Gudalur amounting to Rs.8.95 lakh for the advocacy and publicity expenditure incurred towards disseminating the online admission process for 2020 Admission session under Result Area 2 is ratified.


