ORDER:

In the Government Order 1st read above, an amount of Rs.1.02 Crore (Rupees One Crore Two Lakh only) sanctioned by Government of India to the State of Tamil Nadu towards 10% advance on signing of PBFA under the STRIVE project, was released to the SVEETS Society of the Training Wing of Commissionerate of Employment and Training.

2. In the Government Order 4th read above, a sum of Rs.25.00 Lakh sanctioned by Government of India under Result Area-2 in STRIVE project was released by the State Government.

3. In the letter 3rd read above, the Director of Employment and Training has stated that in order to achieve the target fixed in Key Performance Indicator under Result Area-2 in STRIVE project, it has been proposed to utilize the released funds to upgrade the facilities. Accordingly, agenda has been placed in the State Steering Committee (SSC) held on 15.06.2020 and the SSC has approved the following activities under Result Area 2 of STRIVE project as per the approved costs noted against each of them :-

In the letter 2nd read above, the Director (Projects) Directorate General of Training, Ministry of Skill Development and Entrepreneurship, Government of India has stated that the participating States can utilize incentive funds released under Result Area 2 with approval from their respective State Steering Committee.

5. The Director of Employment and Training has requested the Government to issue the following orders :-

- i. To accord permission to procure standalone AV recorder with required accessories to create high quality digital content to be used for online classes at an estimated cost of Rs.2.03 Lakh.
- ii. To accord permission for hiring the web cloud services from M/s.BSNL for a sum of Rs.39.38 Lakh towards the rent and related data transfer charges for a period of three years
- iii. To sanction a sum of Rs.19.00 Lakh to District Skill Committee in 38 districts at the rate of Rs.50,000/- per district so as to undertake activities like conduct of District Skill Committee meetings and other activities for creating awareness to youth about skill activities imparted by the Department so as to enhance the enrolment of Apprentices in Apprenticeship Training Scheme and also to permit the Assistant Directors of concerned District Skill Training Offices to incur the expenditure.
- iv. To procure the Computers, other peripherals and accessories at an estimated cost of Rs.56.30 Lakh towards strengthening of Directorate so as to handle centralized admission process, MIS Portal and other e-governance related activities.

- v. To accord permission for establishing Language cum Soft Skill Lab in 6 Government ITIs namely, Government ITI, Anaicutti (ST), Gudalur (ST), Jamunamarathur (ST), Kolli Hills (ST), Karumandurai (ST) and Ulundurpet at an estimated sum of Rs.96.92 Lakh under Result Area 2, Increased Capacity of State Governments of STRIVE project. In anticipation of additional grants, permission may be accorded to incur an expenditure of Rs.9.77 Lakh to establish basic facilities for the Language cum Soft Skill Labs in these Government ITIs.
- vi. To accord ratification for the deputation of 55 Instructors of Mechanic Motor Vehicle trade of Government ITIs of the Department, who underwent one day workshop on Electric Vehicles conducted by IIT, Madras on 21.02.2020 which incurred an expenditure of Rs 52,116/-.
- vii. To permit the SPIU to incur the above said expenditure from the advance grants released by Government of India for Result Area 2 from the SVEETS bank account operated for STRIVE project.

6. The Government after careful examination of the proposal of Director of Employment and Training, accept the same and accord permission to the Director of Employment and Training to utilize an amount of Rs.1,27,00,000/- (Rupees One Crore Twenty Seven Lakh only) released by Government of India, as advance grants under Result Area-2 of STRIVE Project, to carryout the following activities under the Project :-

- i. To procure standalone AV recorder with required accessories to create high quality digital content to be used for online classes at an estimated cost of Rs.2.03 Lakh.
- ii. To hire the web cloud services from M/s.BSNL for a sum of Rs.39.38 Lakh towards the rent and related data transfer charges for a period of three years
- iii. To utilize a sum of Rs.19.00 Lakh for District Skill Committee in 38 districts at the rate of Rs.50,000/- per district so as to undertake activities like conduct of District Skill Committee meetings and other activities for creating awareness to youth about skill activities imparted by the Department so as to enhance the enrolment of Apprentices in Apprenticeship Training Scheme and also to permit the Assistant Directors of concerned District Skill Training Offices to incur the expenditure.
- iv. To procure the Computers, other peripherals and accessories at an estimated cost of Rs.56.30 Lakh towards strengthening of Directorate so as to handle centralized admission process, MIS Portal and other e-governance related activities.
- v. To establish Language cum Soft Skill Lab in 6 Government ITIs namely, Government ITI, Anaicutti (ST), Gudalur (ST), Jamunamarathur (ST), Kolli Hills (ST), Karumandurai (ST) and Ulundurpet at an estimated cost of Rs.96.92 Lakh under Result Area 2 of STRIVE Project and to incur an expenditure of Rs.9.77 Lakh initially from the advance grants released under Result Area 2 of STRIVE Project to establish basic facilities for the Language cum Soft Skill Labs in these Government ITIs.

7. The Government also accord ratification for the expenditure of Rs.52,116/- incurred towards deputation of 55 Instructors of Mechanic Motor Vehicle trade of Government ITIs, for one day workshop on Electric Vehicles conducted by IIT, Madras on 21.02.2020.


