MINUTES OF THE STATE STEERING COMMITTEE MEETING HELD ON 10.06.2019 AT 11.00 A.M. IN THE CHAMBER OF THE PRINCIPAL SECRETARY TO GOVERNMENT, LABOUR AND EMPLOYMENT DEPARTMENT, SECRETARIAT, CHENNAI-9.

The 34th State Steering Committee meeting was held on 10.06.2019 at 11.00 AM under the Chairmanship of Principal Secretary to Government, Labour and Employment Department, Secretariat, Chennai-9.

The member Secretary of SSC / the Commissioner of Employment & Training along with other SSC members participated in the meeting. The list of participants is enclosed.

The CET extended a warm welcome to the members of the State Steering Committee (SSC).

The Principal Secretary to Government, L&E permitted the CET to deliberate over the agenda points.

Then the agenda points were taken up for deliberation.

1. Confirmation of minutes of the 33rd SSC meeting conducted on 11.02.2019:

The action taken report on the minutes of the SSC meeting held on 11.02.2019 was presented in the meeting.

The CET also informed that the action taken report had been sent to Government. The Principal Secretary to Government, L&E Department enquired about the status of the proposals submitted by the CET.

The Principal Secretary also enquired about the identification of new industry partner for Government ITI Tenkasi. The Additional Director informed that the new industry M/S S.M.T Hi-Tech Polymer Limited, Tirunelveli has been approved in the SSC Meeting held on 11.02.2019. The Principal, Government ITI Tenkasi has submitted a proposal for reconstitution of IMC, for which recommendation of RJD

Tirunelveli has been requested vide this office letter no.1838/SPIU3/2017 dt.09.05.2019.

The Principal Secretary advised to send proposal with important details of Apprenticeship training to conduct a meeting under the Chairmanship of Chief Secretary with Secretaries of State Public sector establishments.

The Member FICCI, suggested to introduce new technology trades in selected project ITIs. In this regard the Principal Secretary informed that new generation trades are going to be started in the new Centrally sponsored scheme -STRIVE and by implementing STRIVE scheme the seating capacity of 11 Government ITIs will be increased by 4031 seats. The CET also informed the demand driven trade i.e fire Technology and Industrial Safety Management was started in Virudhunagar District under SCVT pattern.

Finally, the minutes and action taken report of the minutes of 33rd SSC meeting held on 11.02.2019 were confirmed.

AGENDA - 1:

Amalgamation of IMC Society of BTC Ambattur with Govt ITI, Ambattur for transferring of BTC Ambattur PPP Scheme activities.

CET explained the about need of the amalgamation of IMC Society of BTC Ambattur with IMC Society of Government ITI Ambattur.

The Principal Secretary to Government, L&E Department enquired about the delay in amalgamation of above said two IMC Societies.

The CET explained that even though the administrative sanction was issued on 28.06.2017, the post deployment G.O. was issued during the month of July 2018 with respect to merger of BTC Ambattur with Government ITI Ambattur. After getting the Government Order the merger activities were made w.e.f 01.10.2018.

Accordingly, scheme merger activities were started and it has been completed smoothly. As per the PPP scheme guidelines the amalgamation of Society can be done as per the provision of Section 14 of Societies Registration Act and with the prior consent of the Registrar and the State Government.

The IMC society of BTC, Ambattur has already been registered as Society.

Now, the IMC of Government ITI, Ambattur has submitted application to register it as Society and registration order is awaited from the Registration Department.

On receipt of registration order, an agenda will be placed in the IMC Society of Government ITI Ambattur to merge the IMC Society of BTC, Ambattur. In order to get approval of SSC for amalgamation, this agenda was placed in SSC meeting.

The Principal Secretary expressed this dissatisfaction over the inordinate delay in placing these agenda before the SSC. Then the SSC accepted this Agenda and instructed to send necessary proposals to DGT, New Delhi for getting approval of the merger.

AGENDA - 2:

Presentation of quarterly progress reports upto 31.03.2019 of 32 PPP ITIs to the perusal of SSC.

CET presented the Quarterly Periodical Reports (QPRs) for the period ended upto 31.03.2019 for 32 Government ITIs covered under Public Private Partnership mode.

The Principal Secretary to Government, L&E reviewed the component wise expenditure of 32 PPP ITIs and observed the poor performance in Government ITIs at Nagercoil, Theni, Needamangalam, Thiruvannamalai, Nagercoil (W), Ranipet, Mudukulathur, BTC Ambattur and Thirukuvalai. He instructed to improve the performance and to take necessary action to utilize the funds for the civil work,

procurement of tools & equipments and other components as per Institute Development Plan (IDP). The Principal Secretary also recorded his utmost unhappiness over the poor performance of these IMCs and strictly instructed to ensure further progress in the days to come.

The CET informed that out of 32 ITIs, 29 ITIs have obtained affiliation orders from DGT, New Delhi. The 29th ITI (Government ITI, Ranipet) got affiliation order for 3 trades / 6 units on 29.04.2019. Totally now 67 new trades with 132 Units got affiliated and 2332 seats have been newly created from inception of the scheme.

Finally, the SSC approved the QPRs and instructed to send the QPRs to DGT, New Delhi.

Agenda No.3:-

Approval of Dovetailed Institute Strategic Plan (ISP) submitted by Government ITIs for the participation in STRIVE project.

CET placed the Dovetailed ISP of 11 Government ITIs and requested for the approval of SSC.

The Principal Secretary to Government explained about the Dovetailed ISP in detail to the Members. Under the STRIVE project, Government of India has not allowed to utilize scheme funds for the new major construction work and recurring staff salary. This point was discussed during the previous SSC meeting held on 11.02.2019. After detailed discussion it was decided to propose new trades / new generation courses in line with market demand, employability and enrollment in the form of dovetailed ISP for 11 Government ITIs selected already by Government of India.

The Special Secretary to Government, Finance Department enquired about financial commitment involved to the State for civil work and regular staff salary.

CET informed that separate proposal will be submitted for the financial commitment involved for the civil work and regular staff under this scheme.

The Principal Secretary to Government, L&E enquired about the trades

proposed in each ITI and the Additional Director, explained in detail about the new

trades proposed in the dovetailed ISP of 11 Government ITIs which consist of new

trades, new generation trades, short term courses and Dual system of training as

per guidelines of DGT, New Delhi.

The SSC accepted this Agenda point and instructed to send proposals to

DGT, Government of India and State Government separately.

Agenda No.4:-

Any other points to be discussed with the permission of Hon'ble Chair.

The member FICCI reminded about the proposal of grant amount of

Rs.10,000/- per trainee for PPP Government ITIs in rural area and Rs.12,000/- per

trainee for PPP Government ITIs in urban area for 20% of seats admitted in the

ITIs towards income generation of the IMC, and also the proposal for absorption of

expenditure by Government towards the salary of contract staffs working in the PPP

scheme being paid by IMC Society.

The Principal Secretary to Government, L&E informed that the above

proposals are under consideration of the Government.

The meeting concluded with vote of thanks by CET.
