Presentation of quarterly progress reports for 01.04.2020 to 30.06.2020 and 01.07.2020 to 30.09.2020 of 32 PPP ITIs to the perusal of SSC

After discussion, the SSC adopted the following resolution:

Detailed discussion with regard to repayment of loan amount to GoI as per scheme guidelines were held. The IMC Chairman, Government ITI, Sankarapuram and Pullambadi (Women) who is also the member of SSC and member of Special Working Group of DGT, New Delhi, Government of India for upgradation of 1396 Government ITIs across the country informed that the IMCs are not in a position to generate revenue to repay the loan, for various reasons already explained in the last meeting. He also requested SSC to hold the repayment of loan till the interim evaluation report of NITI Aayog in PPP Scheme is finalized. The SSC while recording the views of IMC Chairman, Government ITI Sankarapuram, also asked Director of Employment and Training to study the potential of each of these ITIs to generate revenue if any.
