ORDER:

In the letter 1st read above, the Directorate General of Training, Ministry of Skill Development and Entrepreneurship, Government of India, New Delhi has conveyed the sanction of President of India to release an amount of Rs.1.02 Crore (Rupees One Crore and Two Lakh only) towards 10% advance of the fund allocated to the State for incurring expenditure under the component Result Area-2 (RA-2)- Increased capacities of State Government on signing of Performance Based Funding Agreement (PBFA) under the project "Skills Strengthening for Industrial Value Enhancement (STRIVE)" with World Bank assistance and also informed that, the States/UTs are eligible for an advance of 30% on signing the PBFA as per section 3.2.4 allocation of funds of the Operation Manual (OM). The details of the proposed release are given below:

In the G.O. 2nd read above, among others, permission has been accorded to the Commissioner of Employment and Training to start the Skills Strengthening for Industry Value Enhancement (STRIVE) project in the selected Government Industrial Training Institutes of Tamil Nadu and also to open a Savings Bank account for Society for Vocational Education Employment and Training Services (SVEETS) in Bank of India to handle the funds received from Government of India under STRIVE project as per operational guidelines.

3. In the letter 3rd read above, the Commissioner of Employment and Training has requested the Government to release the above said amount of Rs.102.00 Lakh sanctioned by Government of India towards incurring the expenditure under the component Result Area 2-Increased State capacities to Support ITIs and Apprenticeship Training through Public Finance Management System (PFMS), to the SVEETS Society, the designated society for this scheme functioning in the Office of Commissionerate of Employment and Training.

4. The Government after carefully examining the proposal of Commissioner of Employment and Training, accord sanction for release of an amount of Rs.1.02 Crore (Rupees One Crore Two Lakh only) sanctioned by Government of India to the State of Tamil Nadu towards 10% advance on signing of PBFA under the STRIVE project, to the SVEETS Society of the Training Wing of Commissionerate of Employment and Training.

She is directed to include this item of expenditure while sending the proposal for RE/FMA 2019-2020 and also send necessary draft explanatory note for inclusion of this expenditure in the Supplementary Estimates 2019-2020 to Government in Finance (L&E/BG.I) Department at the appropriate time without fail.
