#### ORDER:

In the Government Order 1<sup>st</sup> read above, orders were issued to release an amount of Rs.1.02 Crore (Rupees one crore and two lakh only) sanctioned by Government of India to the State of Tamil Nadu towards 1<sup>st</sup> installment of 10% advance on signing of Performance Based Funding Agreement (PBFA) under the STRIVE project to the SVEETS Society of the Training Wing of Directorate of Employment and Training. Subsequently, in the Government Order 3<sup>rd</sup> read above, sanction was accorded for release of 0.25 Crore.

2. In the letter 3<sup>nd</sup> read above, the Director (Projects), Directorate General of Training (National Project Implementation Unit), Ministry of Skill Development and Entrepreneurship, Government of India, New Delhi has conveyed the sanction of President of India to release an amount of Rs.1.79 Crore towards 30% advance of fund allocated to the State for incurring expenditure under the component Result Area – 2 (RA-2)- Increased capacities of State Government on signing of Performance Based

Funding Agreement (PBFA) under the project STRIVE with World Bank assistance and also informed that, the States/UTs are eligible for an advance of 30% on signing the PBFA as per section 3.2.4 allocation of funds of the Operations Manual (OM). The details of proposed release are given below:

The Government after carefully examining the proposal of the Director of Employment and Training, decided to release an amount of Rs.1.79 Crore (Rupees one crore and seventy nine lakh only) sanctioned by Government of India to the State of Tamil Nadu towards 30% advance of the fund allocated to the State for incurring expenditure under the component Result Area 2 (RA-2)- Increased capacities of State Government under the STRIVE project, to SVEETS Society and also to permit the Director of Employment and Training to carry out the project activities as per STRIVE scheme guidelines and issue orders accordingly.
